#### **SCOPE**

The committee will deal with grievances Received in writing from students / teaching / Non Teaching Staff members as the case may be about any of the following matters:-

- (i) Academic Matters
- (ii) Financial Matters
- Other Matters related to certain misgiving about condition of (iii) sanitation, Preparation of food, availability of transport ,victimization by teachers. Salary related issues etc.

# PROCEDURE FOR LODGING A COMPLAINT

- (i) The aggrieved students / staff members may feel free put up a grievance in writing.
- (ii) The grievance committee will act upon those cases which have been forwarded along with the necessary documents.
- (iii) The grievance committee will assure that the grievance has been properly solved in a stipulated time provided by the cell

# **FUNCTIONS**

- The cases will be attended promptly on receipt of written grievances (i) from the students/Staff.
- the committee will give to the College management about the cases (ii) attended to and the no of cases pending. If any which require directions and guidance from higher authorities.

# POWER OF THE COMMITTEE

In case of grievance the members of the committee are empowered to sort out the problems at their level through discussions with students and staff members as the case may be. In such cases where the members fail to find out any solution then the matter shall be referred to the Director for final commitment

# **EXCLUSIONS**

The grievance redressal Committee shall not entertain the following issues:-

- Decisions and directions issued by the university, Board of technical (i)
- Decisions with regard to award of scholarships, fee concessions, merit (ii)
- Decisions made by institute with regard to disciplinary matter and (iii)
- Decisions by competent authority an assessment and examination (iv)
