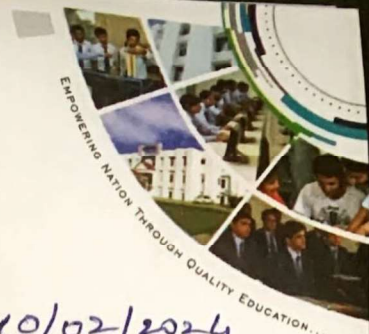

ROLE

The role and responsibility of the food safety committee is to ensure that the standard of food served in the hostel messes as well as in the canteen is of a high standard, nutritious and served in hygienic atmosphere.

FUNCTIONING OF FOOD SAFETY COMMITTEE:

The following are function of Food Safety Committee

- (i) It will be ensured that raw material is procured from the standard sources which maintains the quality.
- (ii) It will be ensured that no loose ration are purchased and the sealed packets bear the date of packing and its expiry date. No item shall be purchased which does not bear the expired date.
- (iii) Cooking materials like cooking oil or vegetable will not be reused and shall be discarded after single use.
- (iv) It will be ensured that storage is in dry, airy, and clean area where no contamination is possible.

- (v) The preparation area is neat and clean with fly proofing. There is adequate arrangement of removal of discarded waste.
- (vi) The persons who are employed in the preparation of food are healthy and fit. Their periodical medical examination record shall be maintained.
- (vii) The persons handling the food during cooking and serving are wearing head gear, aprons and gloves. They are not touching the food with naked hands.
- (viii) There should be adequate arrangement for serving the cooked food in neat and hygienic manner and in warm condition.
- (ix) There is adequate arrangement for disposal of leftover food
- (x) The food shall be checked periodically and the record maintained.
- (xi) Short coming in procurement, storages, preparation and serving if any shall be brought to the notice of director immediately.
- (xii) No Food shall be reserved to students.
