

Roles and Responsibilities:

- i. It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise raids on hostels and other places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places.
- ii. It shall be the duty of Anti-Ragging Squad to conduct an the spot enquiry into any incident of ragging referred to it by the head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of the service provider or by any other person, as the caser may be; and the enquiry report along with the recommendations shall be submitted to the Anti-Ragging Committeefor action. Provided that the Anti-Ragging Squad shall conduct such enquiries observing a fair and transparent procedure and the principals of natural justice.

Penalties

The following penalties may be awarded to the person/persons found guilty of ragging:

- 1. Suspension from attending the classes and the academic privileges.
- 2. With holding/Withdrawing scholarships or benefits.
- 3. Debarring from appearing in any test/examination or any other evaluation process. 4. With holding results.
- 5. Debarring from representing the institution in any regional, National or internation meet Tournament, Youth Festivaletc.
- 6. Suspension/Expulsion from the hostel.
- 7. Cancellation of admission.
- 8. Rustication from institution for a period ragging from 1 to 4 semesters.
- 9. Expulsion from the institution and contently debarring from admission to any institute for a specified period.
